	There is a clear procedure in place for protecting children at risk of radicalisation.	<ul style="list-style-type: none"> <li>• All staff have read the TCAT Safeguarding Policy which includes a statement regarding the "Prevent" duty.</li> <li>• All staff understand how to record and report concerns regarding risk of radicalisation.</li> <li>• The TCAT Prevent Statement is adopted by this school which shows the process for making a referral.</li> </ul>
	The school has identified a Prevent Lead: Sarah Bewes and Steven Burke	<ul style="list-style-type: none"> <li>• All staff know who the Prevent Lead is and that this person acts as a source of advice and support.</li> </ul>
Prohibit extremist speakers and events in the school or college	The school or college exercises "due diligence" in relation to requests from external speakers and organisations using school premises.	<ul style="list-style-type: none"> <li>• Request an outline of what the speaker intends to cover</li> <li>• Research the person/organisation to establish whether they have demonstrated extreme views/actions.</li> <li>• Deny permission for people/organisations to use school or college premises if they have links to extreme groups.</li> </ul>

The school or college is using existing local partnership arrangements in	Staff record and report concerns in line with existing policies and procedures.	<ul style="list-style-type: none"> <li>• All staff record and report concerns to the Prevent Lead or DSLs using the school or college CPOMS system</li> </ul>

	The Prevent Lead makes appropriate referrals to other agencies including the Multi- Agency Safeguarding Hub (MASH) and Channel Panel.	<ul style="list-style-type: none"> <li>Records of referrals are kept on CPOMS</li> <li>Referrals are followed up appropriately (and challenged if necessary).</li> </ul>

	Children are taught about online safety with specific reference to the risk of radicalisation	<ul style="list-style-type: none"> <li>The curriculum reflects this duty.</li> <li>British Values are embedded in the academic and Personal Development curriculum.</li> </ul>
<b>Building children's resilience to radicalisation</b>		
Ensure that pupils have a "safe environment" in which to discuss "controversial issues".
